#### DIGITAL WALLPAPER

Some of you long time DXERS that have most of the countries confirmed, 5BDXCC, WAS and many other awards along with the "wallpaper" that goes with them may like some other challenges that go along with digital communications.

No doubt most of you have been involved with some or most of the digital modes but in case you haven't let me suggest that you try one or all of them. One of the most common is PACKET which has been used for a number of years with PBBS, PACKET BULLETIN BOARD SYSTEMS, used for sending messages nationwide and in some instances to foreign countries. PACKET is also the mode used to access many PACKET CLUSTERS. In addition to PACKET, some of the more common digital modes are AMTOR, PACTOR, RTTY and GTOR provided your TNC is a KANTRONICS. All that is required to use these modes is a TNC, TERMINAL NODE CONTROLLER, a 2-meter radio for VHF PACKET and suitable software. Shareware software is widely available.
