DX! It is what we live for. Even if it does not consume a large part of your amateur radio interest you have a passion that drives you to jump in those pile ups and, once successful, makes you feel like you just crushed one of those beer cans on your head with all your buddies standing around, impressed none the less (don't try that at home kids!).

So, why do we pursue such an activity that can literally take a life time to achieve Honor Roll status in, especially when you have geopolitical forces that can hold you back for years? I can't answer that question. I have pursued a number of amateur radio activities and still enjoy a number of different aspects of it but the one thing that drives me more than any of them is the pursuit of DX.

I know during my 48 years as a licensed radio amateur I have seen situations where I felt some countries were hopeless and would never be on the air. There are several however China, Vietnam and Albania are just a few and today a QSO with those countries is an almost daily occurrence. During our 2018 conference Bernie, W3UR, gave us a run down on the top 10 most needed countries and the prospect of their activation. Some seem slim however things change as it did with the countries I mentioned above. So why do I mention this? Simply because DX is just what I mentioned above, a lifetime pursuit. No one, absolutely no one has achieved Honor Roll in one year and this is part of why the DXCC program is THE premier awards program in amateur radio, bar none!

The number of achievement options are numerous. You have heard me speak about DX goals in previous newsletters. So, how did you fair with your 2019 DX goals?? I've only heard one or two of our fine ADXA folks mention them. Surely there are more! Do NOT, repeat NOT be ashamed of any goal, even if it is as simple as achieving your very first DXCC. We have had three of our members do just that this year! So let's get those identified. Let's make a list regardless what it is and lets see what you accomplish for 2020. My goal is simple although they become more difficult as you "climb the ladder". I actually have two. The first is to hit 3000 on the DX Challenge. I am currently at 2992 and my second is to hit 300 on 160 meters. I am currently at 282. With a bit of luck I should hit the 3000 mark before I hit 300. Bouvet would have helped add 5, maybe six band countries to the list but that doesn't look promising.

The entities that I need the most band countries on are from tough ones on that "Top 10 Most Needed List" like P5, BS7, BV9P, EZ, FT5W and FT5X.

If I can achieve these two goals I will retire from DX'ing! WHAT?????

Absolutely not! There will always be the excitement of a pile up that I just can't stay away from and enjoy or as those geopolitical changes occur countries will be changed. Its a life time of achievement and still more to come.

What are your 2020 goals? Let's state them here and when our annual conference rolls around let's see who made it.

I'm looking forward to our 1st Quarterly meeting in Russellville March 7. Our meeting will begin at 11:30 AM.


